Consider a charitable IRA rollover gift to the Naval Order Foundation

- With a charitable IRA rollover gift, you can help the Naval Order Foundation in its mission to support scholarships through National History Day activities. With your IRA rollover gift, you can support this and also enjoy valuable tax and income benefits.
- If you are 70-1/2 or older, you can roll over up to \$100,000 from your IRA(s) to the Naval Order Foundation without paying federal income tax. Even better, your gift might satisfy part or all of your Required Minimum Distribution (RMD).

Here are some ways you can benefit from an IRA rollover gift this fall

- Reduce your taxable income. By rolling over some or all of your RMD from your IRA or IRAs to the Naval Order Foundation, you can reduce your taxable income for 2024.
- Lower your Social Security tax. Reducing your taxable income with an IRA rollover gift might also reduce the tax due on your Social Security payments.
- Avoid IRS tax limits. IRA rollover gifts can be made to the Naval Order Foundation even if you have already reached the normal limit of your cash gifts for 2024.
- Non-itemizers: Enjoy charitable gift benefits! If you do not itemize your deductions, you can still benefit from the reduction in income and tax that results from an IRA rollover gift.
- A new source for a larger gift. If you wish to make a larger gift to the Naval Order Foundation that's near and dear to your heart, you can make that gift from your IRA rather than tapping into your bank account this year.
